Bhotekoshi Rural Municipality has allocated funds towards the cost of Construction of Rural Municipal Building, Bhotekoshi RM-04, Hindi (Contract No: NCB/BRM-06/076/77) Bhotekoshi Rural Municipality, Fulpingkatti, Sindhupalchok. Bidding is open to all eligible bidders as per Section V of bidding documents.
2. Bhotekoshi Rural Municipality, Office of Municipal Executive invites electronic bids from eligible bidders under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 50.5 Million.
  - Minimum Work experience of similar size and nature: at least 1 (One) contract of Construction of Building, within the last ten (10) years, with a value of at least NRs 53.6 Million that have been successfully or are substantially completed and that are similar to the proposed works.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the Office of Municipal Executive, Fulpingkatti, Sindhupalchok or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
4. Bidder should submit their bid electronically & may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders should deposit NRs. 5000.00 as the cost of bidding document in the Office's Rajaswa (revenue) account as specified below.

5. Pre-bid meeting shall be held at Bhotekoshi Rural Municipality, Sindhupalchok on **2076/07/26** (12th November 2019) at **12:00 hrs**.
6. Bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hrs** on **2076/08/08** (24th November 2019). Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs** on **2076/08/08** (24th November 2019) at the office of Bhotekoshi Rural Municipality, Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format in amounting to a minimum of **NRs. 1.9 Million**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
