5. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp. to office of Bhotekoshi rural Municipality on or before 12:00 hours on 2081/07/23 (08/11/2024). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2081/07/23 (08/11/2024) at the office of Bhotekoshi Rural Municipality, Fulpingkatti, Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to minimum of above mention, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing /submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same specified for the original last date of bid submission.
